General Introduction to the Keystone Exam Assessment Anchors

Introduction

Since the introduction of the Keystone Exams, the Pennsylvania Department of Education (PDE) has been working to create a set of tools designed to help educators improve instructional practices and better understand the Keystone Exams. The Assessment Anchors, as defined by the Eligible Content, are one of the many tools the Department believes will better align curriculum, instruction, and assessment practices throughout the Commonwealth. Without this alignment, it will not be possible to significantly improve student achievement across the Commonwealth.

How were Keystone Exam Assessment Anchors developed?

Prior to the development of the Assessment Anchors, multiple groups of PA educators convened to create a set of standards for each of the Keystone Exams. Enhanced Standards, derived from a review of existing standards, focused on what students need to know and be able to do in order to be college and career ready. (Note: Since that time, PA Core Standards have replaced the Enhanced Standards and reflect the college-and career-ready focus.) Additionally, the Assessment Anchors and Eligible Content statements were created by other groups of educators charged with the task of clarifying the standards assessed on the Keystone Exams. The Assessment Anchors, as defined by the Eligible Content, have been designed to hold together, or anchor, the state assessment system and the curriculum/instructional practices in schools.

Assessment Anchors, as defined by the Eligible Content, were created with the following design parameters:

- ➤ Clear: The Assessment Anchors are easy to read and are user friendly; they clearly detail which standards are assessed on the Keystone Exams.
- Focused: The Assessment Anchors identify a core set of standards that can be reasonably assessed on a large-scale assessment; this will keep educators from having to guess which standards are critical.
- Rigorous: The Assessment Anchors support the rigor of the state standards by assessing higherorder and reasoning skills.
- Manageable: The Assessment Anchors define the standards in a way that can be easily incorporated into a course to prepare students for success.

How can teachers, administrators, schools, and districts use these Assessment Anchors?

The Assessment Anchors, as defined by the Eligible Content, can help focus teaching and learning because they are clear, manageable, and closely aligned with the Keystone Exams. Teachers and administrators will be better informed about which standards will be assessed. The Assessment Anchors and Eligible Content should be used along with the Standards and the Curriculum Framework of the Standards Aligned System (SAS) to build curriculum, design lessons, and support student achievement.

The Assessment Anchors and Eligible Content are designed to enable educators to determine when they feel students are prepared to be successful in the Keystone Exams. An evaluation of current course offerings, through the lens of what is assessed on those particular Keystone Exams, may provide an opportunity for an alignment to ensure student preparedness.

How are the Assessment Anchors organized?

The Assessment Anchors, as defined by the Eligible Content, are organized into cohesive blueprints, each structured with a common labeling system that can be read like an outline. This framework is organized first by module, then by Assessment Anchor, followed by Anchor Descriptor, and then finally, at the greatest level of detail, by an Eligible Content statement. The common format of this outline is followed across the Keystone Exams.

Here is a description of each level in the labeling system for the Keystone Exams:

- Module: The Assessment Anchors are organized into two thematic modules for each of the Keystone Exams. The module title appears at the top of each page. The module level is important because the Keystone Exams are built using a module format, with each of the Keystone Exams divided into two equal-size test modules. Each module is made up of two or more Assessment Anchors.
- Assessment Anchor: The Assessment Anchor appears in the shaded bar across the top of each Assessment Anchor table. The Assessment Anchors represent categories of subject matter that anchor the content of the Keystone Exams. Each Assessment Anchor is part of a module and has one or more Anchor Descriptors unified under it.
- Anchor Descriptor: Below each Assessment Anchor is a specific Anchor Descriptor. The Anchor Descriptor level provides further details that delineate the scope of content covered by the Assessment Anchor. Each Anchor Descriptor is part of an Assessment Anchor and has one or more Eligible Content statements unified under it.
- Eligible Content: The column to the right of the Anchor Descriptor contains the Eligible Content statements. The Eligible Content is the most specific description of the content that is assessed on the Keystone Exams. This level is considered the assessment limit and helps educators identify the range of the content covered on the Keystone Exams.
- PA Core Standard: In the column to the right of each Eligible Content statement is a code representing one or more PA Core Standards that correlate to the Eligible Content statement. Some Eligible Content statements include annotations that indicate certain clarifications about the scope of an Eligible Content.
 - O "e.g." ("for example")—sample approach, but not a limit to the Eligible Content
 - O "Note"—content exclusions or definable range of the Eligible Content

How do the K-12 Pennsylvania Core Standards affect this document?

Assessment Anchor and Eligible Content statements are aligned to the PA Core Standards; thus, the former enhanced standards are no longer necessary. Within this document, all standard references reflect the PA Core Standards.







The Keystone Glossary includes terms and definitions associated with the Keystone Assessment Anchors and Eligible Content. The terms and definitions included in the glossary are intended to assist Pennsylvania educators in better understanding the Keystone Assessment Anchors and Eligible Content. The glossary does not define all possible terms included on an actual Keystone Exam, and it is not intended to define terms for use in classroom instruction for a particular grade level or course.

Acute Angle An angle that measures greater than 0° but less than 90°. An angle larger than a zero angle but smaller

than a right angle.

Acute Triangle A triangle in which each angle measures less than 90° (i.e., there are three acute angles).

Altitude (of a Solid) The shortest <u>line segment</u> between the <u>base</u> and the opposite <u>vertex</u> of a <u>pyramid</u> or <u>cone</u>, with one

<u>endpoint</u> at the vertex. The shortest line segment between two <u>bases</u> of a <u>prism</u> or <u>cylinder</u>. The line segment is <u>perpendicular</u> to the base(s) of the solid. The altitude may extend from either the base of the solid or from the <u>plane</u> extending through the base. In a right solid, the altitude can be formed at the

center of the base(s).

Altitude (of a Triangle) A line segment with one endpoint at a vertex of the triangle that is perpendicular to the side opposite the

vertex. The other endpoint of the altitude may either be on the side of the triangle or on the line

extending through the side.

Analytic GeometryThe study of geometry using algebra (i.e., points, lines, and shapes are described in terms of their

coordinates, then algebra is used to prove things about these points, lines, and shapes). The description


of geometric figures and their relationships with algebraic equations or vice-versa.

Angle The inclination between intersecting lines, line segments, and/or rays measured in degrees (e.g., a 90°

inclination is a right angle). The figure is often represented by two rays that have a common endpoint.

Angle Bisector

A <u>line</u>, <u>line segment</u>, or <u>ray</u> which cuts a given <u>angle</u> in half creating two <u>congruent</u> angles. Example:



Arc (of a Circle)

Any continuous part of a <u>circle</u> between two <u>points</u> on the circle.

Area

The measure, in square units or units², of the surface of a plane <u>figure</u> (i.e., the number of square units it takes to cover the figure).


Base (Three Dimensions)

In a <u>cone</u> or <u>pyramid</u>, the <u>face</u> of the <u>figure</u> which is opposite the <u>vertex</u>. In a <u>cylinder</u> or <u>prism</u>, either of the two faces of the figure which are <u>parallel</u> and <u>congruent</u>.

Base (Two Dimensions)

In an <u>isosceles triangle</u>, the <u>side</u> of the <u>figure</u> which is adjacent to the <u>congruent angles</u>. In a <u>trapezoid</u>, either of the <u>parallel</u> sides of the figure.

Central Angle (of a Circle) An <u>angle</u> whose <u>vertex</u> is at the center of a <u>circle</u> and whose sides are <u>radii</u> of that circle. Example:




Central Angle (of a Regular Polygon)

An <u>angle</u> whose <u>vertex</u> is at the center of the <u>polygon</u> and whose sides intersect the <u>regular polygon</u> at adjacent vertices.


Centroid

A <u>point</u> of concurrency for a <u>triangle</u> that can be found at the intersection of the three <u>medians</u> of the triangle. This point is also the center of balance of a triangle with uniform mass. It is sometimes referred to as the "center of gravity." Example:




Chord

A <u>line segment</u> whose two <u>endpoints</u> are on the <u>perimeter</u> of a <u>circle</u>. A particular type of chord that passes through the center of the circle is called a <u>diameter</u>. A chord is part of a <u>secant</u> of the circle. Example:




Circle

A <u>two-dimensional figure</u> for which all <u>points</u> are the same distance from its center. Informally, a perfectly round shape. The circle is named for its center point. Example:



Circumcenter

A <u>point</u> of concurrency for a <u>triangle</u> that can be found at the intersection of the three <u>perpendicular</u> <u>bisectors</u> of the triangle. This point is also the center of a <u>circle</u> that can be <u>circumscribed</u> about the triangle. Example:



Circumference (of a Circle)

The total measured distance around the outside of a <u>circle</u>. The circle's <u>perimeter</u>. More formally, a complete circular arc.

Circumscribed Circle

A <u>circle</u> around a <u>polygon</u> such that each <u>vertex</u> of the polygon is a <u>point</u> on the circle.

Colinear


Two or more points that lie on the same line.

Composite (Compound) Figure (Shape)

A <u>figure</u> made from two or more geometric figures (i.e., from "simpler" figures).

Cone

A <u>three-dimensional figure</u> with a single circular <u>base</u> and one <u>vertex</u>. A curved surface connects the base and the vertex. The shortest distance from the base to the vertex is called the <u>altitude</u>. If the altitude goes through the center of the base, the cone is called a "right cone"; otherwise, it is called an "oblique cone." Unless otherwise specified, it may be assumed all cones are right cones. Example:



Congruent Figures

Two or more <u>figures</u> having the same shape and size (i.e., measure). <u>Angles</u> are congruent if they have the same measure. <u>Line segments</u> are congruent if they have the same length. Two or more <u>shapes</u> or solids are said to be congruent if they are "identical" in every way except for possibly their position. When congruent figures are named, their corresponding vertices are listed in the same order (e.g., if triangle ABC is congruent to triangle XYZ, then vertex C corresponds to vertex Z).


Conversion

The process of changing the form of a measurement, but not its value (e.g., 4 inches converts to $\frac{1}{3}$ foot;

4 square meters converts to 0.000004 square kilometers; 4 cubic feet converts to 6,912 cubic inches).

Coordinate Plane

A <u>plane</u> formed by perpendicular number lines. The horizontal number line is the *x*-axis, and the vertical number line is the *y*-axis. The point where the axes meet is called the origin. Example:



Coordinates

The <u>ordered pair</u> of numbers giving the location or position of a <u>point</u> on a <u>coordinate plane</u>. The ordered pairs are written in parentheses (e.g., (x, y) where the x-coordinate is the first number in an ordered pair and represents the horizontal position of an object in a coordinate plane and the y-coordinate is the second number in an ordered pair and represents the vertical position of an object in a coordinate plane).

Coplanar

Two or more figures that lie in the same plane.

Corresponding Angles

Pairs of <u>angles</u> having the same relative position in geometric <u>figures</u> (i.e., angles on the same side of a <u>transversal</u> formed when two <u>parallel</u> lines are intersected by the transversal; four such pairs are formed, and the angles within the pairs are equal to each other). Corresponding angles are equal in measure.

Corresponding Parts

Two parts (<u>angles</u>, <u>sides</u>, or <u>vertices</u>) having the same relative position in <u>congruent</u> or <u>similar figures</u>. When congruent or similar figures are named, their corresponding vertices are listed in the same order (e.g., if triangle ABC is similar to triangle XYZ, then vertex C corresponds to vertex Z). See also <u>corresponding angles</u> and <u>corresponding sides</u>.

Corresponding Sides

Two <u>sides</u> having the same relative position in two different <u>figures</u>. If the figures are <u>congruent</u> or <u>similar</u>, the sides may be, respectively, equal in length or proportional.


Cosine (of an Angle)

A <u>trigonometric ratio</u> within a <u>right triangle</u>. The ratio is the length of the <u>leg</u> adjacent to the angle to the length of the hypotenuse of the triangle.

$$\frac{\text{length of adjacent leg}}{\text{length of hypotenuse}}$$


Cube

A <u>three-dimensional figure</u> (e.g., a rectangular solid or <u>prism</u>) having six <u>congruent</u> square faces. Example:



Cylinder

A <u>three-dimensional figure</u> with two circular <u>bases</u> that are <u>parallel</u> and <u>congruent</u> and joined by straight lines creating a lateral surface that is curved. The distance between the bases is called an <u>altitude</u>. If the altitude goes through the center of the bases, the cylinder is called a "right cylinder"; otherwise, it is called an "oblique cylinder." Unless otherwise specified, it may be assumed all cylinders are right cylinders. Example:



Degree


A unit of angle measure equal to $\frac{1}{360}$ of a complete revolution. There are 360 degrees in a <u>circle</u>. The symbol for degree is ° (e.g., 45° is read "45 degrees").

Diagonal

Any <u>line segment</u>, other than a <u>side</u> or <u>edge</u>, within a <u>polygon</u> or <u>polyhedron</u> that connects one <u>vertex</u> with another vertex.

Diameter (of a Circle)

A <u>line segment</u> that has <u>endpoints</u> on a <u>circle</u> and passes through the center of the circle. It is the longest <u>chord</u> in a circle. It divides the circle in half. Example:



Direct Proof

The truth or validity of a given statement shown by a straightforward combination of established facts (e.g., existing axioms, definitions, theorems), without making any further assumptions (i.e., a sequence of statements showing that if one thing is true, then something following from it is also true).

Distance between Two Points

The space showing how far apart two points are (i.e., the shortest length between them).

Edge


The <u>line segment</u> where two faces of a <u>polyhedron</u> meet (e.g., a <u>rectangular prism</u> has 12 edges). The endpoints of an edge are vertices of the polyhedron.

Endpoint

A <u>point</u> that marks the beginning or the end of a <u>line segment</u>; a point that marks the beginning of a <u>ray</u>.

Equilateral Triangle

A <u>triangle</u> where all sides are the same length (i.e., the sides are <u>congruent</u>). Each of the <u>angles</u> in an equilateral triangle is 60°. Thus, the triangle is also "equiangular." Example:



Exterior Angle

An <u>angle</u> formed by a side of a <u>polygon</u> and an extension of an adjacent <u>side</u>. The measure of the exterior angle is supplementary to the measure of the <u>interior angle</u> at that <u>vertex</u>.

Face


A plane <u>figure</u> or flat surface that makes up one side of a <u>three-dimensional figure</u> or solid figure. Two faces meet at an <u>edge</u>, three or more faces meet at a <u>vertex</u> (e.g., a cube has 6 faces). See also <u>lateral</u> face.

Figure

Any combination of <u>points</u>, <u>lines</u>, <u>rays</u>, <u>line segments</u>, <u>angles</u>, <u>planes</u>, or curves in two or three dimensions. Formally, it is any set of points on a plane or in space.

Hypotenuse


The longest side of a <u>right triangle</u> (i.e., the side always opposite the <u>right angle</u>). Example:



right triangle ABC, with hypotenuse AC

Incenter

A <u>point</u> of concurrency for a <u>triangle</u> that can be found at the intersection of the three <u>angle bisectors</u> of the triangle. This point is also the center of a <u>circle</u> that can be <u>inscribed</u> within the triangle. Example:



Indirect Proof

A set of statements in which a false assumption is made. Using true or valid arguments, a statement is arrived at, but it is clearly wrong, so the original assumption must have been wrong. See also proof by contradiction.

Inscribed Circle

A <u>circle</u> within a <u>polygon</u> such that each <u>side</u> of the polygon is <u>tangent to the circle</u>.

Interior Angle An <u>angle</u> formed by two adjacent <u>sides</u> of a <u>polygon</u>. The common <u>endpoint</u> of the sides form the <u>vertex</u>

of the angle, with the inclination of measure being on the inside of the polygon.


Intersecting LinesTwo lines that cross or meet each other. They are coplanar, have only one point in common, have

slopes that are not equal, are not <u>parallel</u>, and form <u>angles</u> at the point of intersection.

Irregular Figure A figure that is not regular; not all sides and/or angles are congruent.

Isosceles Triangle A <u>triangle</u> that has at least two <u>congruent sides</u>. The third side is called the <u>base</u>. The <u>angles</u> opposite

the equal sides are also congruent. Example:




isosceles triangle ABC, with base BC

Lateral Face Any <u>face</u> or surface of a <u>three-dimensional figure</u> or solid that is not a <u>base</u>.

Leg (of a Right Triangle)


Either of the two <u>sides</u> that form a <u>right angle</u> in a <u>right triangle</u>. It is one of the two shorter sides of the triangle and always opposite an <u>acute angle</u>. It is not the <u>hypotenuse</u>. Example:



right triangle ABC, with legs AB and BC

Line

A <u>figure</u> with only one dimension—length (no width or height). A straight path extending in both directions with no <u>endpoints</u>. It is considered "never ending." Formally, it is an infinite set of connected <u>points</u> (i.e., a set of points so closely set down there are no gaps or spaces between them). The line AB is written \overrightarrow{AB} , where A and B are two points through which the line passes. Example:



Line Segment

A part or piece of a <u>line</u> or <u>ray</u> with two fixed <u>endpoints</u>. Formally, it is the two endpoints and all <u>points</u> between them. The line segment AB is written \overline{AB} , where A and B are the endpoints of the line segment. Example:



Linear Measurement A measurement taken in a straight line.

Logic Statement (Proposition)

A statement examined for its truthfulness (i.e., proved true or false).

Median (of a Triangle) A <u>line segment</u> with one <u>endpoint</u> at the <u>vertex</u> of a <u>triangle</u> and the other endpoint at the <u>midpoint</u> of the

side opposite the vertex.

Midpoint The point half-way between two given points (i.e., it divides or splits a line segment into two congruent

line segments).

Obtuse Angle An <u>angle</u> that measures more than 90° but less than 180°. An angle larger than a <u>right angle</u> but smaller

than a straight angle.

Obtuse Triangle A <u>triangle</u> with one <u>angle</u> that measures more than 90° (i.e., it has one <u>obtuse angle</u> and two <u>acute</u>

angles).

Ordered Pair A pair of numbers, (x, y), written in a particular order that indicates the position of a <u>point</u> on a <u>coordinate</u>


<u>plane</u>. The first number, *x*, represents the *x*-coordinate and is the number of units left or right from the <u>origin</u>; the second number, *y*, represents the *y*-coordinate and is the number of units up or down from the

origin.

Origin The point (0, 0) on a coordinate plane. It is the point of intersection for the x-axis and the y-axis.

Orthocenter

A <u>point</u> of concurrency for a <u>triangle</u> that can be found at the intersection of the three <u>altitudes</u> of the triangle. Example:



Parallel (Bases)

Two <u>bases</u> of a <u>three-dimensional figure</u> that lie in <u>parallel planes</u>. All <u>altitudes</u> between the bases are congruent.

Parallel (Lines or Line Segments)

Two distinct <u>lines</u> that are in the same <u>plane</u> and never intersect. On a coordinate grid, the lines have the same slope but different *y*-intercepts. They are always the same distance apart from each other. Parallel <u>line segments</u> are segments of parallel lines. The symbol for parallel is $\| (e.g., \overline{AB} \| \overline{CD}) \|$ is read "line segment AB is parallel to line segment CD").

Parallel (Planes)


Two distinct <u>planes</u> that never intersect and are always the same distance apart.

Parallel (Sides)

Two sides of a two-dimensional figure that lie on parallel lines.

Parallelogram

A <u>quadrilateral</u> whose opposite sides are <u>parallel</u> and <u>congruent</u> (i.e., there are two pairs of <u>parallel</u> <u>sides</u>). Often one pair of these opposite sides is longer than the other pair. Opposite angles are also congruent, and the diagonals bisect each other. Example:



Perimeter The total distance around a closed <u>figure</u>. For a <u>polygon</u>, it is the sum of the lengths of its <u>sides</u>.

Perpendicular

Two <u>lines</u>, <u>segments</u>, or <u>rays</u> that intersect, cross, or meet to form a 90° or <u>right angle</u>. The product of their slopes is $\bar{}$ 1 (i.e., their slopes are "negative reciprocals" of each other). The symbol for perpendicular is $\bar{}$ (e.g., $\bar{AB} \bar{} \bar{}$ CD is read "line segment AB is perpendicular to line segment CD"). By definition, the two <u>legs</u> of a <u>right triangle</u> are perpendicular to each other.

Perpendicular Bisector

A line that intersects a line segment at its midpoint and at a right angle.

π (Pi)

The ratio of the <u>circumference</u> of a <u>circle</u> to its <u>diameter</u>. It is 3.14159265... to 1 or simply the value 3.14159265.... It can also be used to relate the <u>radius</u> of a circle to the circle's <u>area</u>. It is often approximated using either 3.14 or $\frac{22}{7}$.

Plane A set of <u>points</u> that forms a flat surface that extends infinitely in all directions. It has no height.

Plotting Points To place <u>points</u> on a <u>coordinate plane</u> using the *x*-coordinates and *y*-coordinates of the given points.

A <u>figure</u> with no dimensions—it has no length, width, or height. It is generally indicated with a single dot and is labeled with a single letter or an ordered pair on a coordinate plane. Example:



Polygon


Point

A closed plane <u>figure</u> made up of three or more <u>line segments</u> (i.e., a union of line segments connected end to end such that each segment intersects exactly two others at its <u>endpoints</u>); less formally, a flat shape with straight sides. The name of a polygon describes the number of sides/angles (e.g., <u>triangle</u> has three sides/angles, a quadrilateral has four, a pentagon has five, etc.). Examples:




Polyhedron

A <u>three-dimensional figure</u> or solid whose flat <u>faces</u> are all <u>polygons</u> where all <u>edges</u> are <u>line segments</u>. It has no curved surfaces or edges. The plural is "polyhedra." Examples:



Prism

A <u>three-dimensional figure</u> or <u>polyhedron</u> that has two <u>congruent</u> and <u>parallel faces</u> that are <u>polygons</u> called <u>bases</u>. The remaining faces, called <u>lateral faces</u>, are <u>parallelograms</u> (often <u>rectangles</u>). If the lateral faces are rectangles, the prism is called a "right prism"; otherwise, it is called an "oblique prism." Unless otherwise specified, it may be assumed all prisms are right prisms. Prisms are named by the shape of their bases. Examples:



Proof by Contradiction


A set of statements used to determine the truth of a proposition by showing that the proposition being untrue would imply a contradiction (i.e., one assumes that what is true is not true, then, eventually one discovers something that is clearly not true; when something is not not-true, then it is true). It is sometimes called the "law of double negation."

Proportional Relationship

A relationship between two equal ratios. It is often used in problem-solving situations involving <u>similar figures</u>.

Pyramid

A <u>three-dimensional figure</u> or <u>polyhedron</u> with a single <u>polygon base</u> and triangular <u>faces</u> that meet at a single <u>point</u> or <u>vertex</u>. The faces that meet at the vertex are called <u>lateral faces</u>. There is the same number of lateral faces as there are sides of the <u>base</u>. The shortest distance from the base to the vertex is called the <u>altitude</u>. If the altitude goes through the center of the base, the pyramid is called a "right pyramid"; otherwise, it is called an "oblique pyramid." Unless otherwise specified, it may be assumed all pyramids are right pyramids. A pyramid is named for the shape of its base (e.g., triangular pyramid or square pyramid). Example:



Pythagorean Theorem

A formula for finding the length of a side of a <u>right triangle</u> when the lengths of two sides are given. It is $a^2 + b^2 = c^2$, where a and b are the lengths of the <u>legs</u> of a right triangle and c is the length of the <u>hypotenuse</u>.



Quadrilateral

A four-sided <u>polygon</u>. It can be <u>regular</u> or <u>irregular</u>. The measures of its four <u>interior angles</u> always add up to 360°.

Radius (of a Circle)

A <u>line segment</u> that has one <u>endpoint</u> at the center of the <u>circle</u> and the other endpoint on the circle. It is the shortest distance from the center of a circle to any <u>point</u> on the circle. It is half the length of the <u>diameter</u>. The plural is "radii." Example:




Ray

A part or piece of a <u>line</u> with one fixed <u>endpoint</u>. Formally, it is the endpoint and all <u>points</u> in one direction. The ray AB is written \overrightarrow{AB} , where A is an endpoint of the ray that passes through point B. Example:



Rectangular Prism

A <u>three-dimensional figure</u> or <u>polyhedron</u> which has two <u>congruent</u> and <u>parallel</u> rectangular <u>bases</u>. Informally, it is a "box shape" in three dimensions. Example:



rectangular prism

Regular Polygon

A <u>polygon</u> with <u>sides</u> all the same length and <u>angles</u> all the same size (i.e., all sides are <u>congruent</u> or equilateral, and all angles are congruent or equiangular). Example:




Right Angle

An angle that measures exactly 90°.

Right Triangle

A <u>triangle</u> with one <u>angle</u> that measures 90° (i.e., it has one <u>right angle</u> and two <u>acute angles</u>). The <u>side</u> opposite the right angle is called the <u>hypotenuse</u> and the two other sides are called the <u>legs</u>.




Scalene Triangle

A <u>triangle</u> that has no <u>congruent</u> <u>sides</u> (i.e., the three sides all have different lengths). The triangle also has no congruent angles (i.e., the three angles all have different measures).


Secant (of a Circle)

A <u>line</u>, <u>line segment</u>, or <u>ray</u> that passes through a <u>circle</u> at exactly two <u>points</u>. The segment of the secant connecting the points of intersection is a chord of the circle. Example:




Sector (of a Circle)

The <u>area</u> or region between an <u>arc</u> and two <u>radii</u> at either end of that arc. The two radii divide or split the <u>circle</u> into two sectors called a "major sector" and a "minor sector." The major sector has a <u>central angle</u> of more than 180°, whereas the minor sector has a central angle of less than 180°. It is shaped like a slice of pie. Example:



Segment (of a Circle)

The area or region between an <u>arc</u> and a <u>chord</u> of a <u>circle</u>. Informally, the area of a circle "cut off" from the rest by a <u>secant</u> or chord. Example:



Semicircle

A half of a <u>circle</u>. A 180° <u>arc</u>. Formally, an arc whose <u>endpoints</u> lie on the <u>diameter</u> of the circle.

Shape


See figure.

Side

One of the <u>line segments</u> which make a <u>polygon</u> (e.g., a pentagon has five sides). The <u>endpoints</u> of a side are <u>vertices</u> of the polygon.

Similar Figures

<u>Figures</u> having the same shape, but not necessarily the same size. Often, one figure is the dilation ("enlargement") of the other. Formally, their <u>corresponding sides</u> are in proportion and their <u>corresponding angles</u> are congruent. When similar figures are named, their corresponding vertices are listed in the same order (e.g., if triangle ABC is similar to triangle XYZ, then vertex C corresponds to vertex Z). Example:



Sine (of an Angle)

A <u>trigonometric ratio</u> within a <u>right triangle</u>. The ratio is the length of the <u>leg</u> opposite the <u>angle</u> to the length of the hypotenuse of the triangle.


sine of an angle =
$$\frac{\text{length of opposite leg}}{\text{length of hypotenuse}}$$

Skew Lines

Two lines that are not parallel and never intersect. Skew lines do not lie in the same plane.

Sphere


A <u>three-dimensional figure</u> or solid that has all <u>points</u> the same distance from the center. Informally, a perfectly round ball shape. Any cross-section of a sphere is <u>circle</u>. Example:



Straight Angle An <u>angle</u> that measures exactly 180°.

Surface Area The total <u>area</u> of the surface of a <u>three-dimensional figure</u>. In a <u>polyhedron</u>, it is the sum of the areas of all the faces (i.e., two-dimensional surfaces).

Tangent (of a Circle) A <u>line, line segment, or ray</u> that touches a <u>circle</u> at exactly one <u>point</u>. It is <u>perpendicular</u> to the <u>radius</u> at that point. Example:




Tangent (of an Angle) A trigonometric ratio within a g

A <u>trigonometric ratio</u> within a <u>right triangle</u>. The ratio is the length of the <u>leg</u> opposite the angle to the length of the leg adjacent to the angle.

tangent of an angle =
$$\frac{\text{length of opposite leg}}{\text{length of adjacent leg}}$$

Tangent (to a Circle)

A property of a <u>line</u>, <u>line segment</u>, or <u>ray</u> in that it touches a <u>circle</u> at exactly one <u>point</u>. It is <u>perpendicular</u> to the radius at that point. Example:




⇔ is tangent to circle O at point P

Three-Dimensional Figure A <u>figure</u> that has three dimensions: length, width, and height. Three mutually <u>perpendicular</u> directions exist.

Transversal

A <u>line</u> that crosses two or more lines intersecting each line at only one <u>point</u> to form eight or more <u>angles</u>. The lines that are crossed may or may not be <u>parallel</u>. Example:



line f is a transversal through parallel lines I and m

Trapezoid

A <u>quadrilateral</u> with one pair of <u>parallel sides</u>, which are called the <u>bases</u>.

Triangle

A three-sided <u>polygon</u>. The measures of its three interior <u>angles</u> add up to 180°. Triangles can be categorized by their angles, as <u>acute</u>, <u>obtuse</u>, <u>right</u>, or equiangular; or by their sides, as <u>scalene</u>, <u>isosceles</u>, or <u>equilateral</u>. A <u>point</u> where two of the three sides intersect is called a <u>vertex</u>. The symbol for a triangle is Δ (e.g., Δ ABC is read "triangle ABC").

Trigonometric Ratio


A ratio that compares the lengths of two sides of a <u>right triangle</u> and is relative to the measure of one of the angles in the triangle. The common ratios are <u>sine</u>, <u>cosine</u>, and <u>tangent</u>.

Two-Dimensional Figure

A <u>figure</u> that has only two dimensions: length and width (no height). Two mutually <u>perpendicular</u> directions exist. Informally, it is "flat looking." The figure has area, but no volume.

Vertex

A <u>point</u> where two or more <u>rays</u> meet, where two <u>sides</u> of a <u>polygon</u> meet, or where three (or more) <u>edges</u> of a <u>polyhedron</u> meet; the single <u>point</u> or apex of a <u>cone</u>. The plural is "vertices." Examples:



Volume

The measure, in cubic units or units³, of the amount of space contained by a <u>three-dimensional figure</u> or solid (i.e., the number of cubic units it takes to fill the figure).

Zero Angle

An angle that measures exactly 0°.
